Refund Policy, Facility Fees and Misc Info, for the 2011 Keuring

All horses coming from out of state must have a Health Certificate dated within 48 hours of arrival and a notation MUST be made on the Certificate by the Veterinarian that the horse is negative for Equine Herpes (EHV). Negative Coggins Certificate required. Please temp your horses for 2 days prior to arrival at CHP. Horses exhibiting a temp of 102 or above must not be brought on CHP grounds.

Runners:

Our west circuit team will be lead by Robbert van Bergeijk accompanied by Jort de Wit and Willem Houterman.

Owners who decide to use runners the day of the Keuring that have not signed up and pre-paid before September 12, will be required to pay in cash. No exceptions! There will also be a \$10.00 late fee per horse.

Refund Policy:

All cancellations will be assessed an office fee of \$75.00 per horse. The remainder of fees will be considered for refund with the appropriate Veterinarian's Medical Documentation.

Explanation of Facility Fees:

Fees will be per Owner. Fees include use of Outdoor Keuring Arena, Warm Up Arena, Dressage Arena and setup for IBOP horses if necessary. Please note that the CHP donated setup and use of the Dressage Arena, so there are no Dressage Arena fees being divided between any Owners.
